

ENVIRONMENTAL AND ENERGY POLICY

As Brisa management and employees, in line with the Sustainable Development Goals and Bridgestone Environmental Mission Statement, we are committed to reducing the environmental footprint of all our activities and continuously improving our environmental and energy management performance by: We are committed;

- Efficiently using energy and resources for sustainable production in harmony with nature,
- Adopting the principle of protecting the ecosystem through preventive approaches in all our activities, aiming not to pollute but to preserve biodiversity,
- Setting and implementing goals focused on a clean environment and efficient energy usage, and providing the necessary resources to achieve these goals,
- Preferring environmentally friendly and energy-efficient options in the procurement of products and services,
- We ensure the implementation of advanced technologies and continuous monitoring to minimize air pollution (such as NOX, SOX, PM10, VOC emissions), water pollution, and the use of toxic chemicals,
- Raising awareness among our employees and stakeholders through training and communication activities to increase environmental consciousness,
- Aiming to produce with 100% sustainable materials by 2050,
- Reviewing risks and opportunities with a life-cycle approach to improve our environmental performance,
- Transparently reporting our activities and sharing them with stakeholders to contribute to Brisa's sustainability journey,
- Complying with environmental and energy-related legal regulations and other requirements, while exceeding legal standards in environmental practices,
- Supporting the limitation of global warming to 1.5 degrees Celsius, and in accordance with the "Science-Based Emission Reduction" level we have determined, reducing carbon emissions by 56% by 2030 compared to 2020, and achieving net-zero emissions by 2050.
- Using 100% renewable energy (electricity) by 2030, investing in energy efficiency and green energy projects,
- Reducing the water footprint during production operations by decreasing underground water consumption by 85% in the Izmit plant by 2030 compared to 2008, and by reducing water withdrawal per unit production by 70% in the Aksaray plant by 2030 compared to 2019,
- Managing all waste, especially plastic waste generated during production, by adopting the Zero Waste and Circular Economy approach, reducing waste at its source, and ensuring the recycling of generated waste,
- Conducting R&D activities to reduce the environmental impacts of noise and emissions during the use phase of tires, and following evolving technology with the goal of clean production,
- Supporting stakeholder engagement and capacity-building efforts on environmental issues, and enhancing collaboration opportunities by increasing the environmental awareness of our stakeholders.

And in addition, Brisa commits to conduct all climaterelated engagement activities with policy makers in accordance with Paris Agreement.

Scope

This policy applies to Brisa Bridgestone Sabancı Lastik San Tic. Inc.'s production facilities in Izmit and Aksaray, as well as the sales office and technical services in Istanbul.

Responsibility

It is the responsibility of the Occupational Safety and Environment Directorate to review this policy, and the CEO to approve it.
